Illinois Forestry Development Council: Activities for 2014-2015

Illinois forests are significant contributors to the economic and well-being of Illinois citizens and to the ecological vitality of all creatures that inhabit our state. It is important that our Illinois forests are well understood and sustainably managed to ensure their health and importance into the future.

Toward this end, the Illinois Forestry Development Council (IFDC) was created in 1983 with the passage of the Illinois Forestry Development Act (525 ILCS 15) to study and evaluate the nature and extent of the state's forest resources and forest industry, and to provide guidance for sustainability of our forest resources. There are 29 members of the council that are representative of woodland owners, farmers, state and federal land management agencies, forest industries, environmental concerns, the General Assembly and the Governor's office and others. The IFDC serves to nurture and help determine and develop economic and management opportunities for forest owners and rural and urban communities, facilitate promotion of soil, water, and wildlife enhancement actions through management plans, determine the success of incentives necessary to stimulate development of forest resources, and other actions to advance forest stewardship and development in Illinois.

I would like to formally welcome to the Council our new official Director, Bill Gradle. Bill has had a distinguished career in forestry and natural resources and the council is fortunate to have him as Director. Bill will be leading actions of the IFDC including providing administrative support to the Council, solicit and build statewide support for IFDC's short- and long-term strategic goals and recommendations, authoring newsletters and reports on council activities, and other council initiatives. The following is a report on council activities and recommendations for future actions.

Illinois Forestry Development Council Biennial Report – FY2014/2015

Note: This report will cover the last two fiscal years and will return to a single reporting year for FY2016.

During the fiscal years 2013 and 2014, the Council had been involved in a number of statewide forestry issues that affect the delivery of forestry technical assistance and financial technical assistance to private forest landowners and municipal/ urban forestry interests and communities.

Funding was restored to the Council in FY2014 to provide for an Executive Director, administrative support, and grant funding.

All of these current year projects are progressing well as indicated in their quarterly reports.

Council initiatives during the past two years include the following:

- Encouraged the Director of IDNR to select a qualified individual with a forestry degree and a working knowledge of Illinois forestry issue to fill the State Forester position when it became vacant in December 2013. Director Miller selected Tom Wilson, effective June 1, 2014, which met the Councils' criteria.
- Encouraged IDNR to maintain two State operated tree nurseries to provide bare root seedling material and sell those seedlings to the public to offset costs to maintain the two nurseries. The Director has agreed to sell seedlings. The Council has worked with Senator Sullivan to secure funding.
- Encouraged the IDNR to increase available costshare from the 4% pool of funding. FY14 funding was \$80,000. In FY15, this was increased to \$600,000. We thank former Director Miller for the increase.
- Jim Zaczek, Council Chair, announced that effective June 1, 2014, Bill Gradle accepted request to assume the Executive Director position, on a temporary appointment.
- The Council wrote a letter to the Illinois Commerce Commission requesting that when power lines are approved to be built through managed private forestland that landowners be duly compensated for the loss of resources. No response yet from the chairman, Mr. Doug Scott.
- The Council approved a proclamation to designate October as "Oak Awareness Month", sponsored by the Morton Arboretum.
- The Executive Director met twice with new IDNR Director Wayne Rosenthal to discuss Council priorities and goals.

- The Council is working with eleven other forestry groups, state and federal agencies to secure a Regional Conservation Partnership Proposal through USDA that will increase the amount of Environmental Quality Incentives Program dollars available to forest landowners. This will provide increase technical and financial assistance for developing forest management plans and the resources to implement those plans and existing plans.
- The Council met six times during FY15 and is looking forward to working with the new administration and the legislature in updating appointments to the Council.

Other Business



The Council has worked with the other forestry organizations in Illinois, such as the Association of Illinois Soil & Water Conservation Districts, Illinois Walnut Council, Illinois Forestry Association, Illinois Tree Farm System, Illinois Association of Consulting Foresters, Illinois Arborist Association, USDA Forest Service and USDA Natural Resources Conservation Service, to promote forest sustainability. Through IDNR, we have amended

the current Forest Action Plan to include Urban Forestry interests that will make them eligible for State and Private Forestry Grants. The Council will be commenting on the newly revised Forest Action Plan this coming summer.

Invasive Species are proving to be very challenging in the rural and urban forest landscapes. Emerald Ash Borer, the Asian long horned beetle and a number of invasive plants are increasing the need for technical and financial assistance all across the state.

The Council will be working with the other forestry organizations to bring more federal funding into the State through the Regional Conservation Partnership Program

during this next calendar year to address Invasive Species issues.

Illinois Forestry Development Council

This Illinois Forestry Development Council was created back in 1983 upon passage of the Illinois Forestry Development Act (525 ILCS 15). In addition to the members of the Council, several Task Groups work on projects and issues related to private and public woodland ownership, forest resource analysis, forestry outreach and education, legislation, long-range planning, timber marketing and promotion, and urban planning.
